Utilizing Health IT to Connect the Dots for Better Healthcare

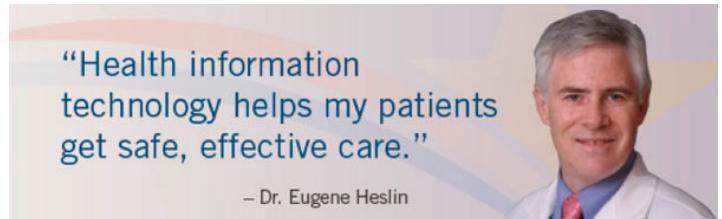

Dr. Heslin Uses Health IT to Improve Diabetes Care



Dr. Eugene Heslin is head physician at Bridge Street Medical Group, a family practice with six physicians in Saugerties, NY. Since implementing an EHR several years ago, Bridge Street Medical Group has used their EHR to improve health care quality for their patients with diabetes. Bridge Street Medical Group redesigned their nursing workflows to integrate microprotein testing—testing that helps physicians discover signs of kidney failure—into their annual diabetes check-ups. Before Dr. Heslin and his practice implemented an EHR, they tested less than 50% of their patients with diabetes for signs of kidney failure. Dr. Heslin and his practice now collect annual microprotein data for 100% of their patients with diabetes.

Deadline Nears to Receive Full Medicaid Specialist Program EHR Incentives and Services

The **Medicaid Specialists Program** is a New York eHealth Collaborative (NYeC) Regional Extension Center (REC) initiative that provides outreach, technical, and support services to help eligible providers adopt an electronic health record (EHR) system to meet the requirements to attain Meaningful Use (MU). The program is a part of the New York State Medicaid EHR Incentive Program to help improve patient care.

The time to enroll is now. There is limited availability and time constraints. Enrollment in the Medicaid Specialist Program EHR Incentive program exceeds 30% as the deadline to receive full services nears. There are two milestones that must be achieved:

- AIU the adoption, implementation, or upgrade of a certified EHR
- Attestation of Meaningful Use

The first milestone (AIU) must be completed by December 31, 2013 to receive the full benefits of the Medicaid Specialist Program. For the first time, specialists are eligible to receive support from the REC for MU incentives and are now encouraged to enroll in this adoption program. The program will help Medicaid Specialists qualify for up to \$63,750 under the Medicaid Incentive Program for the adoption, implementation, and upgrade of a certified EHR and attestation of Meaningful Use Stage 1.
