

N.Y. State Budget Devotes \$1.2B to Realigning Healthcare System

New York state would spend \$1.2 billion to restructure hospitals, long-term care and other healthcare services and invest an additional \$75 million in health information technology, under Gov. Andrew Cuomo's newly released capital budget.

Cuomo's budget calls for grants to "improve the financial viability and efficiency" of the state's hospitals, nursing homes and other healthcare operators. New financing would promote mergers and consolidation; an increase in primary care and care coordination; and efforts that better match supply and demand for hospital and nursing home beds.

The budget plan would also increase spending by \$55 million for New York's health information network. Development of a database to house medical bill records from all public and private health plans would receive another \$10 million. Capital spending would increase by \$10 million for other health information technology initiatives.

Navigating a Medical Records Maze

On Jan. 6, Dr. Gene Heslin and his wife decided they should drive from their home in Saugerties to Albany Medical Center. She was a little past 24 weeks pregnant and suffering from pre-eclampsia, which can cause dangerous high blood pressure, as well as painful swelling caused by a kidney condition.

With the lives of both mother and child in jeopardy, Jeanne Heslin's condition was the sort of critical data puzzle that medical personnel confront dozens of times a day. But in her case, putting the pieces together was considerably easier.

Heslin got out his laptop and accessed his wife's full medical records through his office's secure system. He could also have tapped into them through the Taconic Health Information Network and Community (THINC), the regional databank that serves Saugerties.

The study's results could have broad implications, not only for Kaiser members, but also for millions of others who are expected to use patient portals that are being rolled out to meet the requirements of Meaningful Use Stage 2.
