### Virtual Health Tools Could Save Primary Care Nearly \$10B Annually

The use of virtual health tools in primary care could save nearly \$10 billion each year, **according to a new report** from Accenture, *FierceHealthIT* reports (Hall, FierceHealthIT, 10/20).

According to the American Association of Medical Colleges, the U.S. faces a projected shortage of as many as 31,000 primary care physicians by 2025. Meanwhile, the U.S. in 2010 spent \$2.6 trillion on healthcare, with wages making up more than half of the cost.

According to the report, a combination of virtual health tools and traditional patient care models can offset clinicians' challenges with labor costs and capacity (Landi, *Healthcare Informatics*, 10/19).

According to the report, digital tools—including biometric devices, analytic diagnostic engines, and virtual medical assistants—can help streamline work and allow clinicians to focus on high-value tasks by:

- Automating tasks;
- Replacing labor with technology; and
- Shifting tasks to patients (FierceHealthIT, 10/20).

The report said that virtual health tools can save time and money when applied to:

- Annual patient visits;
- Ongoing patient management; and
- Patient self-care.

The analysis found that using virtual health tools in ambulatory patient settings could save each U.S. primary care provider an average of five minutes per encounter, which amounts to a time savings equal to 37,000 PCPs, or 18% of the PCP workforce. From an economic standpoint, such savings amount to more than \$7 billion annually across the U.S. healthcare system.

### Medicaid Providers are Encouraged to Attest by 12/14/15 to Avoid Payment Delays

Eligible Providers participating in the Medicaid EHR incentive program—who are ready to submit their Attestations to MEIPASS for AIU or Meaningful Use Stage 1, Year 1—are encouraged to do so **prior to December 15, 2015**. The recently released Final Rules and Regulations go into effect on December 15, 2015, at which time the NY MEIPASS website will not be able to accept Attestations. The site will be temporarily under construction to accommodate for the alignment of new objectives and measures as published per the Final Rule. This means that all Eligible Medicaid providers who do not attest by December 15, 2015 will be required to Attest using new objectives and measures as defined in the new rules and regulation, and will have to wait until the website has been updated prior to being able to Attest and receive their EHR Incentive payment. 
# Eligible Professionals Required to Participate in PQRS Reporting in 2015 to Avoid Compound Negative Medicare Payment Penalty in 2017

The 2015 Physician Quality Reporting System (PQRS) reporting year, also known as the performance year, is critical for all Eligible Professionals (EPs) to participate and report their quality measures. Physicians who do not submit PQRS measures in 2015 will be automatically be subject to a **-2%** payment adjustment to their Medicare Part B billing in Payment year 2017. Eligible Physicians that fail to report their 2015 measures **will also** be subjected to a **-2%** adjustment based on their Value Modifier (VM) based on a quality tiering rating. Successful participation in the 2015 PQRS reporting year allows solo practitioners and groups with of up to 9 providers to potentially receive up to a **+2%** incentive payment for their Medicare Part B billing. Practices with 10+ EPs participating in PQRS and earning a positive rating in their VM score have the potential to receive a combined **+4%** incentive payment. Neglecting to participate in reporting or failing to meet satisfactory VM performance could result in a **-4%** payment adjustment for these practices/provider groups.

NYeC is offering PQRS Registry services starting with the 2015 reporting year. NYeC's CMS certified PQRS Registry supports all 175 individual Measures and 22 Specialty Measure Groups. NYeC can support GPRO reporting services for those organizations that have registered to use this reporting method.
