Call for Applications for New York Digital Health Accelerator 2016 Class

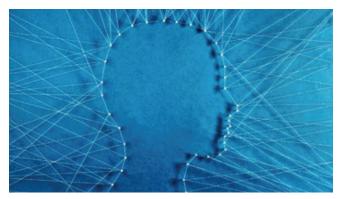

Twenty-one graduates of this highly successful program have raised nearly \$230 million since leaving the program, and have created over 160 jobs in just three years. Two alums—Avado and Remedy Systems—have been acquired. The program is distinctive from other healthcare accelerator programs, offering unique exposure to top-level healthcare executives and venture capitalists while helping entrepreneurs accelerate customer acquisition and access to capital..

Why HIE Data Analytics are Critical for Behavioral Healthcare



In the healthcare industry, "interoperability" is more than just a technical term for the way electronic health record systems shuffle information back and forth. It's a concept that can—and should—be applied to the connections between organizations across the care continuum, from primary care and specialty services to inpatient admissions, long-term care, and especially behavioral healthcare.

Historically, many of these disciplines have operated with a certain sense of isolation. Hospitals and specialists treated acute problems and performed surgeries; family doctors dealt with everything else. Communication between them was limited to the tedious faxing of hundreds of pages of records, which may or may not contain pertinent information in an easily accessible way.

Behavioral healthcare existed somewhere off to the side as an option for those who specifically sought it out.

PQRS Reporting for 2016: Are you Ready?

GPRO reporting provides an excellent method for group practices to share their measures and leverage the effort to complete PQRS reporting. **June 30th is the CMS deadline for group practices to self-nominate for GPRO reporting**. Practices with two

or more eligible providers that bill under a single TIN are eligible to select this PQRS reporting methodology.

To support the provider community as healthcare shifts from Fee for Service to Pay for Performance and Value, NYeC provides a CMS-qualified PQRS Registry for all Eligible Professionals (EPs) to submit their quality measures for the 2016 PQRS Reporting Year. We are a full service registry that supports all 280 Individual Quality Measures, Measure Group, and GPRO reporting methodology.

We offer both Basic and Premium support levels and practices/providers can use our registry to report as individuals or as a GPRO. Services include measure selection guidance, data collection tools, training, monthly webinars, and support calls.
