MACRA: HHS issues final rule to enhance the reliability, transparency, accountability, and safety of certified health IT

On October 14, 2016, the U.S. Department of Health and Human Services (HHS) announced a final rule to implement key provisions of the bipartisan Medicare Access and CHIP Reauthorization Act of 2015 (MACRA) in a new program called the Quality Payment Program. The Program advances Medicare's value-based transformation for hundreds of thousands of physicians and other eligible clinicians by tying these payments to quality patient care. A number of the provisions in MACRA directly relate to the use of certified electronic health record (EHR) technology and health information technology (health IT), including the Advancing Care Information performance category under the Quality Payment Program. The Advancing Care Information category will modernize, streamline, and replace the Medicare EHR Incentive Program for eligible professionals (also known as "Meaningful Use"). The Quality Payment Program advances the use of certified EHRs and health IT as tools to improve the flow of health information among clinicians and, ultimately, improve the quality of care provided to patients.

Cancer Moonshot Task Force Report Released

This month, Vice President Joe Biden delivered a new Cancer Moonshot report to President Barack Obama. The report, which details the past year of work and outlines a five-year plan for moving forward, identifies data as the key to breakthroughs in the Cancer Moonshot initiative. The Vice President detailed challenges and barriers that stand in the way and notes that, "ultimately, we have to build a network—centered on the patient—that makes data accessible, shareable, and meaningful," Biden's report states. "And we must advance a modern, interoperable electronic health ecosystem, with patient access and sharing capabilities between clinical care providers and research."

HealtheConnections Consent Process Expanded to Include 10-17 Years Old



Authorized users of the health information exchange can now access patient records for minors ages 10 through 17 years old. Previously, there had been a restriction on consent for this age group, which permitted providers to enter a minor's record only in an emergency situation. This change expands access for providers to more comprehensive medical records for patients under 18 years of age, and is especially important for pediatricians, family practitioners, hospitals, and clinics.

Parents can provide consent for children ages 10 through 17 years old. When a patient turns 18, s/he will consent for him/herself. Using the same consent forms already in place at your facility, parents can select 'Yes', 'No', or 'No, except in an Emergency' for all children under 18 years of age. Emancipated minors* may provide their own consent using the same consent options that are available to all other patients.

*An emancipated minor (any person who is the parent of a child, has married, or is otherwise legally emancipated) may give consent for medical, dental, health and hospital services for him/herself and the consent of no other person shall be necessary.

Attestation Portal

Launch of the new Meaningful Use attestation portal has been delayed due to issues found during testing. The NYS Department of Health wants to make sure that the system operates smoothly for the provider community. November 30th Deadline to File Appeal for 2017 PQRS Payment Penalties

CMS released provider's QRUR reports on September 26, 2016. Practices and providers who participated in the PQRS program in 2015 should review these reports to confirm if they will receive a payment penalty in 2017. These reports inform providers about their success in reporting PQRS and how CMS rated their cost efficiency. Performance ratings, as reported in the QRUR report, determine if a -2% to -6% penalty will be applied to all their Medicare Part B billings in 2017. Providers can request and informal review with CMS, if they believe their scores are not accurate. The deadline is November 30th to file these informal review requests. QRUR reports are available for review; to access your report follow this link: [How to Obtain a QRUR](#). Providers access these reports and file an informal review request via the EIDM system.
