Don't miss the March 17, 2017 PQRS Reporting Deadline!

March 17, 2017 is the reporting deadline for providers to submit their Physician Quality Reporting System (PQRS) data to the **NYeC PQRS Registry**. Eligible Professionals (EPs) that bill Medicare Part B Fee-For-Service to the Centers for Medicare and Medicaid (CMS) are required to participate in the PQRS program to avoid negative payment adjustments in 2018.

NYeC's PQRS Support Team is available to support and guide you through this process. Our CMS-Qualified Registry supports all reporting measures for practices of any size, nationwide.

The New York State Department of Health is offering incentives to eligible provider organizations that connect their electronic health record systems to the HIE and begin to contribute data by September 30, 2017.

"The value of the HIE is only as good as the data it contains," explains Christina Galanis, President and CEO of HealthlinkNY. "If a provider gets consent from a patient to look up the patient's complete medical history and it isn't in the HIE, it doesn't do the provider or patient much good."

Medical Orders for Life Sustaining Treatment, MOLST Registry to Share Data with Healthix



Healthix is recently announced a partnership with Excellus BlueCross BlueShield to provide Healthix participants with Medical Orders for Life-Sustaining Treatment (MOLST) data. MOLST, approved by NYSDOH in 2008, is a clinical process that emphasizes the discussion of a patient's goals for care including shared medical decision making between healthcare professionals and patients who are seriously ill or frail. The result is a standardized set of medical orders documented on the MOLST form that reflect the patient's preferences for life-sustaining treatment. MOLST has an electronic completion and registry online—the only in the nation—known as eMOLST. The partnership between Healthix and Excellus BCBS will give providers access through the HIE to the medical orders and wishes for an end-of-life patient. This is targeted to go live in Q2' 2017. rability.

Modified Stage 2 Meaningful Use functionality will be available in the coming weeks. What is the Behavioral Health Information Technology (BHIT) Program?

NYeC will assist eligible NY State Adult Home and Community Based Service (HCBS) behavioral health providers from the Rest of State (ROS) to adopt Electronic Health Records or upgrade their electronic systems to meet HCBS Medicaid Managed Care (MMC) documentation and billing requirements.
