

## SHIN-NY Consent: Considerations for the Future

With the expansion of healthcare transformation efforts in New York State, including the implementation of DSRIP and a focus on improving care coordination, consent issues related to the sharing of patient health data have been among the challenges to the successful achievement of these efforts.

In 2016, the **SHIN-NY Policy Committee** embarked on a review and assessment of the current SHIN-NY consent policies to better understand the key factors of the framework. Stakeholders who currently participate in the SHIN-NY were surveyed to gather information on their perceptions about consent and how to improve the framework going forward. In-depth, follow-up interviews were also conducted with a targeted group of survey respondents to obtain further clarification on issues raised in their responses. In addition, a roundtable of attorneys with expertise in New York State healthcare law was convened to ascertain what opportunities for change or reinterpretation of the framework might exist, especially within the laws related to sharing of sensitive health information.

As an output of the consent policy review and assessment, NYeC developed a **SHIN-NY Consent White Paper** outlining three possible approaches to creation of a new consent framework for consideration by NY State.

## HEALTHeLINK Milestones Reached for Patient Queries and Alerts in 2016



### HEALTHeLINK™

With more data sources and physician practices utilizing HEALTHeLINK, approximately 2.5 million patient records were securely accessed through the exchange in 2016 alone.

Participating HEALTHeLINK providers are notified in real-time with alert notifications of their patients' admissions, including emergency department visits and discharges and transfers from local hospitals and long-term care facilities. Through this functionality, providers can be prepared sooner with the patients' transitions of care. As of yearend 2016, 816 providers have subscribed 300,254 of their patients for alert notifications. A total of 234,059 alerts were delivered in 2016.

## Survey: How will Healthcare Data Change in the Next 5 Years

40 percent of respondents to a new survey said genomic data will become one of the most useful sources of healthcare data in five years, up from just 17 percent today. And 40 percent said patient-generated data will be a top source of data in five years, opposed to 30 percent listing it as a top source today.

"The landscape is shifting from one of despair over the unfulfilled promises of big data to a more realistic vision of what sophisticated analytics can do to transform care delivery," wrote Dr. Amy Compton-Phillips, chief clinical officer for Providence St. Joseph Health, who authored the report.
