

# **Big Picture Update**



Dear NYeC Community,

It's been a little while since you've heard from me and I thought it'd be a good opportunity to take a moment and provide you with a few updates on NYeC and our progress.

As you'll recall from our January newsletter, NYeC has been working closely with our stakeholders and the State to

develop a multi-year roadmap to define the continued evolution of the **Statewide Health Information Network for New York** (SHIN-NY). Focused on increasing adoption (especially physicians), data contribution, and usage of important **core services**, the roadmap will move us towards our goal of a transformed healthcare system where health information exchange is universally used as a tool to make lives better.

Over the past few months, I've visited a number of stakeholders across the state, meeting with the NYS DOH, physician groups such as ACP, MSSNY, hospital groups like HANYS and GNYHA, and the Suffolk Care Collaborative Project Advisory Committee (PAC), among many others, collecting input. It's great to see all the fantastic work being done around the state. As part of my meetings and presentations, I've been providing updates on the progress of the SHIN-NY Strategic Planning We continue to work with stakeholders to refine the SHIN-NY, listening to them to better understand their needs to drive our development of long-term objectives, features, and operational plans.

Last month, we also provided an update on the work of the SHIN-NY Policy Committee. In 2016, the committee embarked on a review and assessment of current consent policies, the output of which was a **whitepaper** outlining three possible approaches to the creation of a new consent framework for consideration by NY State. We're exploring new ways of consent to ensure the model is fully consistent with the goals of improving clinical care and controlling costs. We invite you to **provide comments** on the proposed frameworks. Finally, I wanted to share with you a high-level **2016 Year in Review** we presented at our last board meeting. This snapshot highlights progress and accomplishments of NYeC and the SHIN-NY, as well as key QE successes. It also outlines how the SHIN-NY supports various value-based care initiatives and fits into the larger healthcare ecosystem, advancing care statewide.

Thank you for your continued collaboration—it will truly take a concerted community of intelligent, passionate, and dedicated professionals working together to guide the evolution of healthcare.

# A Small Behavioral Health Agency Thinks Big with HealthlinkNY



Search for Change is a small non-profit that operates supportive housing and vocational training programs in Westchester and Putnam counties for adults diagnosed with severe mental illness. Eligible for New York State's **Data Exchange Incentive Program** (DEIP), which was expanded to include behavioral health providers, Search for Change recently connected with HealthlinkNY. HealthlinkNY's Web Portal allows Search for Change to immediately benefit from the connection by accessing records, building up the infrastructure for a bi-directional interface between their EHR and the HIE, and improving the quality of life for its supported individuals.

HealtheConnections has established connections to the Veterans Administration (VA) and Department of Defense (DoD) within the last few years, to allow healthcare providers to access veteran and active military patient health records. A new feature has been added to Patient Lookup to improve the process for HealtheConnections users, thereby eliminating the extra steps needed to submit a guery.

# **Real-Time Alerts Now Available Across** Most of New York State

# Hixny

Phase 2 of the Cross Qualified Entity Alerts (XQE) initiative has been completed, enabling real-time notifications when patients, with consent, are admitted to or discharged from hospitals in other parts of the state.

In this phase, Hixny has joined health information exchanges (HIEs) in two more regions, HealthlinkNY and HealtheConnections, to offer alerts. In phase 1, Hixny set up XQE alerts with two downstate HIEs—New York Care Information Gateway and Healthix. The HIEs include some of the largest hospitals in New York City and Long Island.

Phase 3 of the XQE initiative will bring the Bronx RHIO, Rochester RHIO, and HEALTHELINK on line with the entire state and is expected to be completed this fall.

#### **Quality Reporting Moving Forward**

NYeC successfully concluded its 2016 PQRS Quality Reporting Year on March 31st. As CMS sunsets this quality reporting program, NYeC is actively in the process of developing its MACRA/MIPs Registry services. Providers who reported via our PQRS Registry are already a step ahead; PQRS data can be evaluated as a baseline for the new reporting requirements.

CMS approved NYeC as a MACRA/MIPs full-service registry, which means we will support all components of the program's reporting requirements. This new reporting program will combine three independent reporting programs into one: Meaningful Use, PQRS, and the cost and utilization component from Value-Based-Modifier. Additionally, there is a fourth reporting component, Advancing Care Information, streamlining measures and focusing on interoperability, information exchange, and security measures.
