

### **Patient Care Alerts Now Available Statewide**

We recently announced the expansion of patient care alerts across the state's eight regional health information exchanges through the **Statewide Health Information** Network for New York (SHIN-NY). The statewide expansion of this service further enhances the SHIN-NY's patient care coordination capabilities and creates an integral resource in improving health and care delivery, including reducing hospital readmissions, throughout the state.

Alerts allow participating SHIN-NY providers and care team members who have treating relationships to receive real-time updates about their patients. For example, a subscribing provider can receive an Admittance, Discharge, Transfer alert if their patient enters or is discharged from a hospital. This promotes timelier interventions and improved planning for a patient's care at home or at another facility. Alerts are a basic core service offered free of charge to S HIN-NY participants.

Prior to the expansion of the service, SHIN-NY participants could only receive alerts from providers connected to the same Qualified Entity. Now, alerts are available throughout the state, regardless of where a patient receives care.

## The Benefits of Health Information Exchange: An Updated Systematic Review

The Journal of the American Medical Informatics
Association (JAMIA) recently published a literaturereview assessing the impacts of health information exchange (HIE). In the review, researchers identified 24 research studies published between May 2014 and June 2017 that included63 analyses that evaluated HIE impact and all reported positive benefits derived from HIE. Multiple New York State HIEs were included in the review.

Researchers found community health information exchanges, such as the Statewide Health Information Network for New York, were more likely to produce benefits than proprietary or enterprise health information exchanges. The new findings provide further evidence that HIEs reduce both the cost of healthcare and its utilization and show progress in reaching national goals for better health, lower costs, and improved population health.

# NYeC Responds to CMS' Proposed Inpatient Payment System and Long-Term Care Hospital Prospective Payment Systems Rule

In late April, the Centers for Medicare & Medicaid Services (CMS) released proposed changes and a request for stakeholder feedback to the Medicare and Medicaid Electronic Health Record (EHR) Incentive Programs. The proposed changes reflect CMS's focus on interoperability, patient data access, and system-wide health information exchange. NYeC submitted comments in response to the proposed rule. While we're in general support of the proposed changes, and we appreciate CMS's focus on reducing provider burden and accelerating interoperability, our comments provide ways to ensure the new approach still prioritizes participation in health information exchange and highlight how to expand and reinforce existing efforts.


### Healthix Forms Population Health Committee

### Rochester RHIO: A Word about Open Notes and DEIP Funding

In a recent Medical Director's Corner, Rochester RHIO's Medical Director, Tarun Kothari, MD, addresses the national Open Notes movement as well as the work that the organization is doing to support <a href="Mew York State's">New York State's</a> <a href="Data Exchange Incentive Program">Data Exchange Incentive Program</a> (DEIP).

The DEIP is managed by NYeC and offers incentive dollars to eligible providers who connect to a Qualified Entity, such as Rochester RHIO. Eligible practices may receive up to \$13,000 in incentives to offset the cost and efforts of health information exchange adoption. In order to receive funding, all milestones must be completed by September 30, 2018.

### Medicaid Eligible Professionals Program (EP2) Update

The Medicaid Eligible Provider Program (EP2) is up and running! The 2017 attestation reporting period for the NYS Medicaid EHR Incentive Program is opening soon and the EP2 Program, with its complimentary support services, can help you successfully report on the necessary Promoting Interoperability (formerly known as Meaningful Use) objectives to receive your 2018 incentive payment.

At no cost, NYeC's EP2 team works with individual providers and practices to ensure eligibility, develop workflows, and advise on the attestation process. During this collaborative period, the EP2 team also guides providers and practices on ways to prepare for potential audits.

Eligible providers could receive up to \$34,000 in incentive payments (\$8,500 for each participation year) through the New York Medicaid EHR Incentive Program.
