The SHIN-NY Answers the Call for Social Determinants of Health

NYeC recently submitted the SHIN-NY as an innovation and a creative way to improve patient outcomes through social determinants of health as a part of the New York State Department of Health's Social Determinants of Health "Call for Innovations' Initiative". Out of over 200 applications, NYeC was selected to participate in a poster board presentation session to showcase our proposed innovation to approximately 500 attendees during the Social Determinants of Health Innovation Summit.

NYeC and the SHIN-NY's shared mission with the Qualified Entities to improve healthcare by collaboratively leading, connecting, and integrating health information exchange across the state makes the organization an ideal partner to promote usage of and exchange of nonclinical data elements like Social Determinants of Health by potentially leveraging the existing SHIN-NY infrastructure.

Data Exchange Incentive Program (DEIP) Extended

The New York State Department of Health, with support from the Centers of Medicare & Medicaid Services, recently granted a two-year funding extension for the **Data Exchange Incentive Program (DEIP)**. The program provides funding to eligible healthcare providers to connect to one of the state's **Qualified Entities** and exchange health data through the **Statewide Health Information for Network (SHIN-NY)**.

Since its launch in 2015, DEIP has enrolled over 650 organizations and has distributed close to \$5 million incentives to New York providers reaching data sharing milestones. NYeC manages DEIP and administers the payment of incentives to providers on behalf of the New York State Department of Health.

FYI: EP2 Program Updates!

Final Reminder of 2017 Attestation Reporting Deadline: Today, October 31st

If you missed the 2017 attestation reporting period in MEIPASS, you might still have an opportunity to attest! The deadline to request an Attestation Deadline Extension (ADE) for Payment Year (PY) 2017 is today, October 31, 2018. Eligible Providers (EPs) may use this form to request a deadline extension by providing evidence that extenuating circumstances, beyond the provider's control, prevented the provider from attesting in MEIPASS by the deadline. NYS DOH will review all ADE requests and if granted, EPs will have until November 30, 2018 to attest in MEIPASS for PY 2017.

The ADE Request Form can be found here on the NY Medicaid EHR Incentive Program website (under General Program Information) and must be submitted by October 31, 2018 to attestation@health.ny.gov.

EP2 CEHRT Upgrade Preparation Webinar on November 13th

Attention New York Medicaid EHR Incentive Program participants: Payment Year 2019 is fast approaching! Beginning in PY 2019, all EPs must have 2015 edition Certified Electronic Health Record Technology (CEHRT) to continue on the path towards Promoting Interoperability. The EP2 team will be hosting an educational webinar on November 13, 2018 discussing strategies for preparing for this upcoming transition to 2015 edition CEHRT.

MURPH Registration Deadline for 2018 MU Attestations

Eligible Providers must register their intent to submit data to the appropriate Public Health registries before or within 60 days from the start of their EHR Reporting Period! For those attesting to 2018 Meaningful Use, the last day to register is December 1st. EPs who previously registered with MURPH, and need to make any changes, must update their existing MURPH Registration rather than start a new registration.
