Most patients receive care from more than one doctor, practice, or hospital. Even with relatively simple healthcare needs, keeping track of and coordinating information among doctors can be a daunting task.

To help patients' healthcare providers better coordinate their care, New York State created the [Statewide Health Information Network for New York \(SHIN-NY\)](#) to connect healthcare professionals, and with patient consent, allow the electronic exchange of clinical information. The SHIN-NY is a statewide network that facilitates secure and confidential sharing of patient data across the healthcare system to increase the quality of care, improve patient outcomes, and reduce unnecessary costs.

PointClickCare Version 3.7 and Netsmart Meet DEIP Privacy & Security Requirements

As of December 2018, PointClickCare (PCC) version 3.7 is the most recent product to meet the [Data Exchange Incentive Program \(DEIP\)](#) privacy and security requirements (as well as ONC certification for other criteria). PCC is the third EHR vendor to attest to meeting the DEIP privacy and security requirements and they join Netsmart technologies which also serves numerous providers in NYS.

By meeting the DEIP requirements, more long-term and post-acute care (LTPAC), behavioral health, and other organizations using these systems throughout New York State are able to access DEIP funding. The DEIP is intended to offset the one-time connection costs incurred by Licensed Facilities (Article 28 SNFs and DTCs, Article 36 Home Health Agencies/Programs and Article 40 Hospice), Behavioral Health Organizations and physician practices when connecting to a Qualified Entity (QE).

PointClickCare supports over 200 organizations throughout New York State and has already built connections to six QEs including HealtheConnections, Hixny, Healthix, HEALTHeLINK, HealthlinkNY and Rochester RHIO. Additionally, Netsmart provides services to approximately 170 customers throughout New York State and has already established connections to all of New York's QEs. NYeC would like to thank PointClickCare and Netsmart for their work in meeting the DEIP privacy and security requirements and consistent communication with the NYeC team.

Attention NY Medicaid EHR Incentive Program Participants!

Happy New Year! As it is now 2019, Eligible Professionals (EPs) participating in the NY Medicaid EHR Incentive Program will now be required to report for Meaningful Use Stage 3 and to be using 2015 edition CEHRT. The EP2 team, offering its complimentary support services, can help EPs successfully report on the necessary Promoting Interoperability (formerly known as Meaningful Use) objectives to receive their incentive payment with these new 2019 program requirements.

Additionally, any EPs must register their intent to submit data to the appropriate Public Health registries before or within 60 days from the start of their EHR Reporting Period. Eligible Professionals who previously registered with MURPH, and need to make any changes, must update their existing MURPH Registration rather than start a new registration. NYeC offers [free NYS PCMH services](#) to help practices deliver high-quality, coordinated care, earn payment incentives, prepare to thrive under value-based payment arrangements, and achieve New York State Patient-Centered Medical Home recognition.
