NYSDOH Releases DSRIP 2.0 Proposal, Seeks Public Input

The New York State Department of Health (NYSDOH) announced in mid-September that it had released for public comment a proposal to extend New York's Medicaid Delivery System Reform Incentive Payment (DSRIP) waiver for an additional period of four years and seek an additional \$8 billion in federal funding for continued support of health care transformation in the state.

"Transforming Medicaid to improve health outcomes and make it more cost-effective has been a priority in New York State under Governor Cuomo's leadership," said NYSDOH Commissioner Dr. Howard Zucker. "Extending our Delivery System Reform Incentive Payment waiver is vital to building upon our success."

Event Alert: NY Medicaid Population Health Symposium



The symposium will provide a forum to share the perspectives and insight of the Delivery System Reform Incentive Payment Program (DSRIP) Performing Providers Systems, Physical and Behavioral Health Providers, Managed Care Organizations, and community organizations addressing the Social Determinants of Health. The goal of the summit is to provide a platform for these perspectives on advancing VBP and gain understanding for further discussion.

NYeC's Valerie Grey, Healthix's Todd Rogow, and AIRnyc's David Shilane, will participate on a panel led by AIRnyc CEO, Shoshanah Brown, "The Value of CBO Participation in the SHIN-NY/Healthix: Interoperability for Addressing SDH." AIRnyc is a community-based organization whose Community Health Workers meet people where they live to improve health, connect families to social care and build health equity at the community level.

SHIN-NY Learning Collaborative Meets

On October 23rd, a Statewide Health Information Network of New York (SHIN-NY) Learning Collaborative was convened. The purpose of the meeting was to share project interim findings and best practices for the New York State Innovation Model QE Quality Measurement pilots and QEs projects with the Bureau of Community Chronic Disease Prevention.

Moving forward, this group will continue to collaborate and discuss lessons learned from each of their projects to inform future Quality Measurement activities across New York State.

HITAC Updates, Recommendations

The Health Information Technology Advisory Committee (HITAC) held its final meeting of 2019, approving recommendations to be submitted to the Office of the National Coordinator for Health Information Technology (ONC) on priority uses of health information technology (HIT) in the areas of orders and results, closed loop referrals and care coordination, as well as medication and pharmacy data.

The group also finalized recommendations to refine the public process for submission and review of new data elements for inclusion in the U.S. Core Data for Interoperability (USCDI). As currently proposed, the ONC would require that all certified HIT products support the USCDI standard which would evolve over time. The HITAC committee then turned their attention toward the year ahead and explored potential areas of focus including data privacy and secondary uses, price transparency, prior authorization, the EHR reporting program, Trusted Exchange Framework and Common Agreement and information blocking implementation.

The Data is Available – Now What?



The transition to value-based care (VBC) is a process, not a decision—one that requires long-term thinking, and integration into everyday work. Hixny CEO Mark McKinney reflects on how providers have been successful in adopting VBC into their workflows to improve patient care:

"I liken it to someone who says they want to get fit, so they buy a home gym. If they begin using that equipment regularly, making it part of their daily life, then they'll almost certainly improve their fitness. If they don't use it — or only lift a weight occasionally—then they'll still be saying they want to get fit next year."

Healthix Delivering 'Smart Alerts' to Clinicians

Coordinating patient care across multiple providers requires the ability to track changes in their conditions at a moment's notice. Clinical event notifications can be a major boon to know when a patient is admitted, discharged, or transferred from medical facilities. Healthix is taking that one step further with new "smart alerts."

Pulling data from across New York State through its connection to the SHIN-NY, Healthix is now generating alerts to notify providers when there are significant changes to a patient's clinical record. This includes diagnoses, significant changes in lab values, and frequent visits to the emergency department.

Clinicians have the option to receive these alerts through multiple channels, allowing them to integrate the latest patient updates into their workflow.

Get Help Getting Connected

The Data Exchange Incentive Program (DEIP) — It is Exactly What it Sounds Like

With the DEIP, eligible organizations like yours can receive a financial incentive to help offset the cost of connecting and contributing data to the SHIN-NY through a QE.

The program is available to Medicaid Providers in New York State at the following facilities:

- Article 28 Skilled Nursing Facility
- Article 28 Diagnostic and Treatment Center
- Article 36 Home Care Agency
- Article 40 Hospice
- Behavioral Health Organization (OMH, OASAS or HCBS)
- Organizations with at least one provider that has attested to and been paid under the Medicare or Medicaid MU program (any year, any stage)

Improve Healthcare Delivery Through Promoting Interoperability Program

Eligible Providers can qualify for financial incentives by achieving care quality milestones.

The Medicaid Eligible Professional Program (EP2) would like to congratulate the many providers who are now celebrating their completed attestations for the Promoting Interoperability 2018 Program Year. The work being accomplished across New York State to realize transformational objectives and advance patient care is exemplary.

As Eligible Providers (EPs) move forward confidently into Program Year 2019, there are items that the EP2 Technical Agents recommend be addressed sooner, rather than later:

- 1. Security Risk Assessment (SRA) Eligible professionals must attest to a security risk analysis being conducted for each EHR reporting period to ensure the privacy and security of their patients' protected health information.
- 2. If you have not done so already, run 2019 Stage 3 reports. These will assist in identifying a 90-day period suitable for attestation purposes, as well as identify area(s) in which reinforcement is required.
- 3. Register with the Meaningful Use Registration for Public Health (MURPH). The final day to do this is December 1, 2019. Note: If you previously completed your registration in MURPH, then you do not need to submit a new registration. You may edit an existing registration if necessary.
- 4. Recertify Electronic Transmitter Identification Number (ETIN). ETIN numbers must be recertified on an annual basis, and lapsed ETINs will cause delays in payment.

Most importantly, Eligible Providers/organizations are encouraged to access the complimentary, personalized support services provided through the New York eHealth Collaborative EP2 Program. We are currently scheduling visits across New York State to prepare providers for successful Stage 3 attestations.
