Successful NCQA Pilot Program Proves Utility of QE Data for HEDIS Reporting

NYeC, in partnership with the New York State Department of Health and the National Committee for Quality Assurance, worked with three of the state's Qualified Entities (QEs) to lead a groundbreaking Data Aggregator Validation pilot program.

The pilot was designed to directly respond to the needs of health plans to reduce administrative burdens on providers and plans associated with HEDIS reporting. It focused on developing protocols and processes to evaluate data received by entities known as data aggregators, which include health information exchanges. The pilot resulted in certification of the data aggregatorgenerated output files for distribution to health plans and inclusion in HEDIS reporting. The protocols and program will serve as a basis for subsequent implementation of a national certification program to standardize electronic clinical data for use in these types of quality and performance measurement activities.

HEALTHeLINK, Hixny, and HealtheConnections were the three QEs that were selected to participate in this pilot. All three successfully completed the pilot program, becoming the first in the nation to receive this certification, valid for one year, allowing them to share data with health plans for HEDIS reporting from their approved data sources.

The pilot was a great success and NYeC looks forward to further opportunities like this to further prove and refine the ability of the SHIN-NY to support quality measurement and other clinical informatics activities.

NYeC Submits Comments on USCDI Version 2

On October 27, NYeC submitted recommendations and supportive comments to the Office of the National Coordinator for Health IT (ONC) for the inclusion of three new data elements in the next version of the US Core Data for Interoperability (USCDI) — a baseline set of data classes and elements required for nationwide health information exchange. The USCDI ultimately replaces the data set currently exchanged, the Common Clinical Dataset, as required by the Cures Act.

NYeC's comments supported the addition of Gender Identity and Sexual Orientation to the USCDI Version 2, both of which are in widespread use today and provide clinical value for LGBTQIA individuals. Further, NYeC recommended the inclusion of Provider Telecom Information, which can capture multiple methods for contacting a provider. Capturing this information is critical for the routing of patient event notifications in support of the Center for Medicare and Medicaid's (CMS') interoperability rule.

NYeC is also proud to be an active supporter in the Gravity Project Community Collaborative, a national collaborative to advance interoperable social determinants of health. The Gravity Project submitted detailed comments to ONC on the USCDI v2, reflecting input from over 1,200 community members.

Bronx RHIO Supports Integrated Care for Kids Project (BE-InCK NY)



The Bronx RHIO is a member of the partnership council for Bronx Equity — Integrated Care for Kids (BE-InCK NY), a CMS-funded project of the New York State Department of Health and Montefiore Medical Center. The project grant funds a seven-year data-driven effort by the NYS DOH to improve children's health statuses in eight key Bronx zip codes.

The project aims to model and implement integrated care networks and promote care management for children through creating a close partnership between health care providers, community-based organizations, health homes for children, city agencies and managed care plans.

Bronx RHIO will be providing data aggregation and analysis services to BE-InCK which include adding a variety of new data sources for access by BE-InCK partners through the RHIO. It is also leveraging collaboration between the Bronx RHIO and Healthix, who will be sending data to the Bronx RHIO from its members participating in the project.

Long Island-based Advantage Care Diagnostic and Treatment Center (DTC), a facility providing ambulatory health services, continued to offer its comforting, personalized patient experience — even throughout the pandemic.

Advantage Care credits Healthix' COVID-19 Alerts and the modifications allowing for verbal consent to deliver telehealth, as essential to the continuity of their medical and mental/behavioral health care services when in-person visits were limited. This organization received over a hundred COVID-19 Alerts on test results and accessed Healthix data through the telehealth workflow in as many times, during the peak of the outbreak.

Eligible Providers have extended opportunity to Attest to Stage 3 Objectives

Eligible Providers take note! The final payment years (2020 and 2021) of the NY Medicaid EHR Incentive Program will offer an extended period within which to complete MEIPASS Attestations.

As of October 1st, Eligible Providers who have met all Meaningful Use Stage 3 criteria, gathered their data, and are ready to attest, may begin their Attestation before (Soft Opening) and through the Official MEIPASS attestation period. The Soft Opening functions in the same way as the official opening, with remediation and review processes that mirror what providers are used to.

For Payment Year 2020, Eligible Providers may attest any time from now through the Official MEIPASS closing date in early 2021. Keep in mind all criteria must be met:

- Payment for 2019 Attestation must have been received prior to participation in the Soft Opening
- All Stage 3 Objectives and their Measures must have been met or excluded from
- Reports and data are gathered for documentation
- The Security Risk Assessment has been completed prior to attestation
